GUARANTEES OF THE SHAREHOLDERS' RIGHTS IN THE LIGHT OF EVOLVING JUDICIAL PRACTICE OF ARBITRATION COURTS

The article considers the recent trends in the practice of arbitration courts in cases of builder's bankruptcy. The article analyzes a number of acts of the Presidium of the Supreme Arbitration Court of the Russian Federation that have changed the approach to judicial protection of citizens as non-professional investors. The Presidium has formulated the basic principle that should guide all arbitration courts – the main purpose of the adoption of special rules of builders' bankruptcy is to provide priority protection of citizens – participants in the construction as non-professional investors, so the application of these regulations should be directed at achieving this goal, rather than hindering it.
